Care & Maintenance Instructions

Regular inspections and attention will help extend the longevity of your storage organizational units, prevent costly repairs, and protect you from voiding your product's warranty.

CLEANING MAINTENANCE:

Cleaning your ClosetMaid wire, melamine or laminate products, we recommend using a soft cloth and mild soap. Rinse thoroughly with warm water, and dry with a clean, soft cloth.

For our melamine or laminate products - To ensure a safe application, test your cleaning solution on a small area before you apply it to the entire surface.

AVOID AT ALL COST:

Never use cleaners containing abrasives materials to clean with. Don't use metal tools or sharp objects, like razor blades, putty knives, and abrasive pads. Avoid petroleum-based products, caustic cleaners/solvents and hydrochloric/phosphoric acid.
